

### **Evolution of Safe Babies Program**

1996	Baby Molly
1997	BC Children's Commission and MCFD review of infants in care - recommendations
1998	Pilot project introduced in Victoria
2000	Gradual expansion across the province
2003	Regional foster parent support agencies contracted to provide peer support and/or training for foster parents
2007	Vancouver Island Safe Babies Collaborative Planning Committee is formed to review program re succession planning & sustainability
2009	Revision of curriculum
2010	Rotman Award

## BC Children's Commission recommendations

- Reform foster care system specialized training, support and respite
- Education for professionals and families on the treatment of infants with FASD/NAS
- Education for professionals and families about Shaken Baby Syndrome
- Consideration of placement with extended family members

## Victoria MCFD internal review recommendations:


- Develop a joint protocol between MCFD and the hospital to guide planning for the discharge of high risk infants
- Recruit foster parents with an interest and ability to care for special needs children
- Develop a network of support for professionals and foster families
- Place babies with NAS with specially trained foster families

### Overall objective of training program

- To provide foster parents, social workers and other community professionals with the knowledge and skills required to care for substance-exposed infants, providing:
- An optimal physical, social, emotional and safe environment;
- An opportunity to maximize early child development; and
- Minimal potential for harm such as Shaken Baby Syndrome
